- All referees appointed to Men’s Premiership Fixtures are to arrive at the grounds dressed in a professional manner, it is an expectation that you will wear the FSC Referees Polo with black pants and dress shoes
- Members appointed to Women’s and Community League Fixtures at a minimum should wear their FSC Referee’s Polo Shirt.
- As a minimum senior referees and juniors doing senior lines must as a minimum carry the following uniform in their kit bag:
 - Short Sleeve Black Shirt
 - Short Sleeve Yellow Shirt
 - Long Sleeve Black Shirt
 - Short Sleeve Red Shirt
 - Black Shorts
 - Black Socks
 - Spray jacket
- Referees are encouraged to purchase additional uniform in case of emergency or any other circumstances
- Along with their uniform referees need to ensure they carry whistles, flags, cards, watch and any other equipment required for your match
- All referees are to be dressed alike: ie, all wearing black shirt, or all wearing yellow shirt. Where there is a clash of colors, alternate strip to be worn.
- In cold and wet weather situations, only assistant referees are permitted to wear the FSC approved spray jacket. Under no circumstances are track pants to be worn whilst in the centre or on the line
- Where possible all referees should be in identical uniforms, however as a minimum standard the 2 assistant referees must be matching be in both in short sleeve, long sleeve or rain jacket

- If undergarments are worn, they must be black, short sleeve only, no full leg length undergarments are permitted
- Plain black caps only, may be worn by assistant referees only
- Under no circumstances are members to wear any uniform items that display any logos other than those as provided by Football South Coast approved uniform supplier. Any member who is found to be wearing any uniform items other than FSC approved uniform supplier will be subject to:
 - *First Occurrence - \$50 fine for 1st offence*
 - *Subsequent Breaches - 100% of match fees and will be requested to attend a meeting with the Referee Council to explain their actions.*

ANY FINES INCURRED BY MEMBERS MUST BE PAID INTO FSC NOMINATED BANK ACCOUNT WITHIN 5 BUSINESS DAYS. ANY FINES NOT PAID WITHIN THIS TIMEFRAME WILL BE AUTOMATICALLY DEDUCTED FROM MEMBERS MONTHLY MATCH PAYMENTS. IF SAID MEMBER IS NOT DUE ANY MONTHLY MATCH PAYMENTS, SAID MEMBER WILL BE INVOICED ACCORDINGLY.
