It should be noted that suspended players must serve their suspension in the Australia Cup, Bampton/Youth Cup and/or in regular season matches (whichever comes first). Suspensions cannot be served in trial matches unless players were sent off in pre-season matches.

Playing suspended players without prior written authorisation in trial fixtures carries potential further penalties.

You are also reminded of the following clauses from the FSC Disciplinary and Disputes Regulations (article 11.4): n) Special consideration may be given by FSC to applications in writing from Clubs for participation by a suspended player, in pre-season trials or friendlies for the purposes of contract or trial negotiations in FSC sanctioned matches.

In granting permission, the suspended player will be subject to playing under a 'two match good behaviour bond' which will be added to any suspension handed down by the Match Review Committee or Tribunal should this suspended player be sent off in the pre-season and found guilty of an R1, R2, R3 or R6 offence as well as any carry over suspension. o) Applications under 11.4 (n) above must be made in writing to Football South Coast in adequate time for appropriate consideration – (no less than 7 days). Each case will be determined on its merits by the Executive in consultation with the Disciplinary Commissioner whose decision shall be final.
