Dear Member Clubs,

This is another update on clubs and the NSW Government's Active and Creative Kids program - where we're up to is this:

- 1. Clubs have been applying and being approved to be a provider under the Active and Creative Kids Voucher scheme
- 2. Families are generating their vouchers through Service NSW and bringing them to clubs, and
- 3. The API is working in our registration platforms

We have an initial set of clubs that are approved, and so now we need to continue updating that approved list in the registration platform.

Once a club is approved, Service NSW periodically provides a list of business IDs, which we then incorporate into the registration platform. Football NSW has received this morning another batch of business IDs and we're seeking confirmation from the registration platform provider how long it takes for that to be incorporated such that the new clubs can go live – for reference, FA have advised that business IDs provided this morning are already live in PlayFootball.

Our big challenges are now almost entirely related to getting clubs approved to be providers. Most clubs' issues relate to challenges in proving that the person applying on behalf of the club is connected to the club in the event that that person is not listed in the Australian Business Register (ABR), **and** that a letter of authority cannot be provided.

In this case, the advice from Service NSW has been that fallbacks could include:

- A letter from the State Sporting Organisation (SSO, ie FNSW) (signed by the SSO CEO or a Director and with the official letterhead) stating that the individual is authorised to apply for that organisation
- A letter from the President of the organisation (signed by the President and with an official letterhead if possible) stating that the individual is authorised to apply for that organisation
- A screenshot from the organisation's official website showing the individual is linked to the organisation

• Service NSW may accept AGM minutes in extenuating circumstances

The final three points are all in the hands of the club itself, but the first point is not.

Service NSW has advised us that whilst they understand that Football NSW (as the State Sporting Organisation or SSO) may be more remote from local clubs than district associations, they would still prefer if letters endorsing people as representatives of their clubs came from Football NSW.
