Please see updates and reminders below on various Women's Football matters.

1. TRIAL GAMES

It is important that all trial matches are sanctioned for insurance purposes. Please use the online form for all trial requests (home/away) | <u>https://form.jotform.co/52720609422854</u>

Particularly for home games, we need a minimum 7-day notice. Clubs run the risk of not having games sanctioned where late notice is provided.

Clubs contacts on the form will receive an approval notice once the application has been processed.

A reminder, referee appointments for trials are published on the web from around midday Thursday.

2. MATCH BALLS

We have taken delivery of the match balls for 2024. Clubs are encouraged and welcome to collect these from the office ASAP. Each club gets 10 match balls.

If you purchase additional match balls from Deploy, you might notice they have just released a new design. Providing clubs purchase the Stealth, FSC approves the use of the alternate design balls.
