### Members

We received from your Club, an Expression of Interest to nominate teams in the Junior Competition for 2025. The club will need to confirm your participation by nominating teams for the respective Junior competitions, by **23<sup>rd</sup> February 2025 in Dribl and the online form.**

Note: Mini Roo nomination form is separate and will be sent out in March.

### DRIBL

Teams are to be created by the Club in Dribl as outlined in [Memo 25-02](#). By 23 February, eleven (11) players need to be assigned to teams (U13 – U18) and 9 players to U12 teams. As there have been significant issues with *Let's Play Football* in registering players, we have attached a workbook **Missing Player Template** which the Club can use to indicate players who are registering or who have not been placed on the team list in Dribl by the due date. Please do not include players who you have allocated to the team in Dribl – FSC will be able to access these. This workbook will need to be uploaded by the Club **via the nomination form**.

Any Division 1 or Division 2 nomination must comply with the Player Movement Rule. If a club wishes for dispensation to be considered then [dispensation request form](#) must be submitted either before or on 23 February. Note if dispensation is given, then the team will be ineligible for State competitions. Players should be informed that there is no guarantee that dispensation will be approved and should consider registering to another club.

### TEAM NOMINATION ENTRY SUMMARY (COMPULSORY)

As part of the nomination process, the workbook (**Team Nomination Entry Summary**) will be required for uploading via the nomination form.

You will need to simply enter the number of teams in each competition, (which reflects those created in Dribl).

## ADDITIONAL INFORMATION – OPTIONAL

Any additional information on reasons for a particular division request for any of your teams is to be submitted on club letter head and saved as a pdf file. This will be uploaded via the nomination form

Please note – Appeals may not be considered if relevant information was not provided with the nomination form.

## UNIFORM

FSC requires that clubs provide an updated photo of their shirt, shorts and socks and clash strip as per this example:



Please have a clear photo which will be uploaded via the nomination form and be used in the clash matrix booklet. We do not want humans in the photo!

### Page 3: Friday Night Matches Question

A current lux certificate must have been submitted to the office where a club wishes to host Friday night matches.

Upload clash strip (if applicable)

## Page 4: Nominations

A question asking if teams have been created in Dribl.

*Upload the Team Information Entry Summary.*

A question asking if you have allocated the required players per team.

If no, then *Upload the Missing Player Template.*

An option to upload a pdf - *Additional Information.*
