The above grant is currently open and supports the Australian Government's commitment to deliver social benefits in communities across Australia by funding projects in each of the 151 Federal electorates. The program provides grants for community projects to strengthen and benefit local communities and is part of the Government's 2024-2025 budget initiatives.

The objective of the program is to deliver infrastructure projects that provides social benefits for local communities across a number of areas including (but not limited to) below which may be relevant to your club or Association

- Support or celebrate Indigenous Australians
- Address gender inequality or discrimination in access to public infrastructure or sport
- Enable or foster the use of electronic communications.
- Support the participation and settlement of newly arrived (i.e. within the last 5 years) immigrants who are not citizens
- Support the dignity of persons (including children) with disabilities by enhancing their access to public infrastructure

You must be able to complete your project no later than 31 December 2025. To be eligible you must have approval from your Member for Parliament so if interested, please reach out to your local Minister to register your interest and obtain their support.

Federal Election

A reminder the next Federal Election will be held before 17 May 2025. Now is the time to prepare your project documentation should you wish to approach prospective or current sitting candidates for financial support.
