Public Liability Certificates of Currency – Now Available Online

The new public liability insurance Certificates of Currency (**CoCs**) for 2025-2026 are now available online.

To Download your Certificate of Currency (CoC)

1 – Click on the **FNSW CoC** link: <https://www.gowgates.com.au/sport-programs/football-nsw#coc>

2 – Click on ‘**Select Association**’ and select one of the following options:

- Your Association name
- FNSW NPL and State League clubs
- FNSW Regional Branches
- Futsal Centres
- Futsal State League Clubs
- Referee Association
- Summer Football Centre

3 – Click on ‘**Select Club**’ and select your Club.

4 – If your club requires a Council named on the CoC, tick the ‘**Note Member Council**’ box and select the relevant Council. If not, proceed to Step 5.

5 – Select the ‘**Download**’ button and the CoC will download as a PDF document.

If your club or Council is not listed, scroll down in the CoC section and complete the CoC request form.
