Football South Coast have now set up the 2026 registration types. Clubs can commence setting up their products for next season.

There is a “bulk roll-over” feature in the registration area which allows your registrar to bring over products they used in 2025. When using this feature, the product will appear as draft in the 2026 registration with steps 1 – 5 already completed. Your terms and conditions with any additional questions from last season will also be brought across.

For each product, select edit and then update any information in steps 6 – 10

- Step 6: Details ... There shouldn't be a need to make any changes except possibly the dates. **Click next**
- Step 7: Payment options ... This is the step which requires updating. Check payment options, update club fee and any exemptions.
Please note you can see the breakdowns for FA, FNSW and FSC. Also, the total fee range can be viewed next to your fee. **Click next**
- Step 8: Terms and conditions. If you have updated your T&C then replace the current **pdf file** or if wish to include a further **pdf** document, this can be added, otherwise keep the existing T&C and **click next**.
- Step 9: Additional Questions: Update, delete or create any new questions or use the same again. **Click next**.
- Step 10: Review and publish

Notes:

1. FSC has set the registration window for amateurs to open from Monday 5th January to close on 30th June.

Clubs could adjust these dates at any time either to start later or finish earlier. Also, clubs could close the product later by simply changing the closing date.

2. FA has set the registration window for professionals (PL 1 clubs only) Wednesday 14th January 2026 to Tuesday 10th February 2026.

3. In step 7, you will notice that for three governing bodies there may be a negative amount for the **current variation fee**.

This is applied to a participant who has deregistered in 2026, registers to another club under the same registration type (e.g. a junior player U12) and who still has a status of paid or paid in full.

As the participant has paid the FA, FNSW fees then they would only be charged the new club fee and any Association admin fees, if applicable.

However, if the player registers to a different registration type in our Association (e.g. Community Registration 13 – 18 and then 16 – 18 Men's PL 1 and 2) then only the FNSW and FA components would be applied.

Where a full refund was issued then on re-registering the participant would be required to pay all the fees of each body.

We are seeking further information on what would happen for clubs who decide to pay the regulation fees for the participant via subsidised payment re the current variation fee being applied.

4. The following registration types are to be used for clubs who require to set up new products

1-1 Community Competition (6 – 18)	Junior playing in community comps
1-3 Community Competitions – Adults (19+)	Community Comps (U19 or All Age or Masters)
1-4 Women's Premiership and Men's PL 3 – Junior 16 - 18	Juniors 16 – 18 playing in either the WPL or MPL 3
1-5 Women's Premiership and Men's PL 3 – Junior 16 - 18	Amateur adults playing in either the WPL or MPL 3
1-6 Men's PL 1 and PL 2 Amateur Adult	Amateur adults playing in either the MPL 1 or MPL 2
1-7 Men's MPL 1 – Professional Players	Professional player in MPL 1 – requires contract.
1-8 Men's PL 1 and PL 2 – Junior (16 – 18)	Juniors 16 – 18 playing in either the MPL 1 or MPL 2
1-20 Referees	DO NOT USE – for FSC only
5-1 FSC Team Official (Coach)	Team Coach
5-2 FSC Team Official (Manager)	Team Manager
5-3 Committee Member	Club committee member
5-4 Volunteer	Club volunteer
8-2 Tournament Adults (18+)	Adults - Only used for sanctioned tournaments by FSC, FNSW (e.g. Jamberoo 7's)
8-3 Tournament Adults (Junior)	Juniors - Only used for sanctioned tournaments by FSC, FNSW
