Dear Members,

In 2025, we received an Expression of Interest from your Club, to nominate teams in the FSC Adult Competitions for the 2026 Winter Season.

As we prepare for the upcoming season, clubs should now be actively registering players via Play Football and confirming their participation by nominating teams into the relevant competitions. Team nominations must be completed by COB on Thursday 19th February 2026 through Dribl and the online nomination form.

The nomination fee is \$330 per team. Once your nomination form has been received, FSC will issue an invoice, which will be payable within 2 working days.

DRIBL

Clubs are required to create their teams in Dribl, as outlined in [Memo 26-05](#). Each team must have 15 players allocated by 19 February 2026 who intend to participate in the season. If you experience any issues or need support, please contact the Competition Coordinator.

When nominating divisions, please refer to the [2025 draft grading](#) as a guide. If your club is requesting placement in a different division, additional information outlining the reasons must be provided on club letterhead and uploaded with the team nomination entry summary form.

Please Note:

1. Please only allocate players to teams they genuinely intend to play for. Accurate player information is essential to help us correctly structure competitions and divisions.
2. If a team has changed clubs since the 2025 season, the 2025 grading will still apply to that team.

TEAM NOMINATION ENTRY SUMMARY (COMPULSORY)

As part of the team nomination process, clubs are required to provide the name and email address of the nominated team referee for each team.

Attached is the **Team Nomination Entry Summary workbook**, which must be completed and uploaded via the online nomination form.

Please ensure you:

- Enter the number of teams nominated in each competition (this must match the teams created in Dribl), and
- Provide the name and email address of the team referee for each team (one referee per team).

ADDITIONAL INFORMATION (OPTIONAL)

If your club is requesting placement in a division different from the grading guide, any supporting information must be provided on club letterhead and submitted as a PDF file with your nomination.

Please note that appeals may not be considered if relevant supporting information is not included at the time of nomination.

Page 1 - Club Details

Page 2 - Team Information & Acknowledgements

- Acknowledgement that FSC may reject a nomination if teams are not listed in Dribl or if insufficient players are allocated
- Upload the Team Nomination Entry Summary
- Optional upload of a PDF containing additional information (if applicable)

Page 3 - Fees

- Acknowledgement that nomination fees MUST be paid within 2 working days of the invoice being issued.
