### Members

We received from your Club, an Expression of Interest to nominate teams in the Junior Competition for 2025. The club will need to confirm your participation by nominating teams for the respective Junior competitions, by **19<sup>th</sup> February 2026 in Dribl and the online form.**

Note: Mini Roo nomination form is separate and will be sent out in March.

### DRIBL

Teams are to be created by the Club in Dribl as outlined in [Memo 26-05](#). By 19 February, eleven (11) players need to be assigned to teams (U13 – U19) and 9 players to U12 teams.

#### U13 – U19

When nominating divisions in Dribl, please refer to the 2025 draft grading as a guide. If your club is requesting placement in a different division, additional information outlining the reasons must be provided on club letterhead and uploaded with the team nomination entry summary form.

Any Division 1 or Division 2 nomination must comply with the Player Movement Rule. If a club wishes for dispensation to be considered then [dispensation request form](#) must be submitted either before or on 19 February.

**Note** if dispensation is given, then the team will be ineligible for State competitions. Players should be informed that there is no guarantee that dispensation will be approved and should consider registering to another club.

#### U12

All teams are to be nominated in the division - Grading. Where a club has 2 or more teams, differentiate the teams by using A, B, C under group in the team set-up. Do not use colours.

All nominations must comply with the Player Movement Rule – If your club wishes to be considered for dispensation then submit the [dispensation request form](#) on or before 19 February.

**Note:** The highest graded team in your U12 is A, then B, etc.

## NOMINATION FORM – PREPARE THE FOLLOWING FIRST:

### TEAM NOMINATION ENTRY SUMMARY (COMPULSORY)

As part of the nomination process, the workbook (*Team Nomination Entry Summary*) will be required for uploading via the nomination form.

You will need to simply enter the number of teams in each competition, (which reflects those created in Dribl).

### PLAYING HOME MATCHES ON FRIDAY NIGHT

A question will be asked re hosting games on Friday night. A current lux certificate must have been submitted to the office where a club wishes to host Friday night matches.

### UNIFORM

Go to the FSC website and check the [Junior Clash Strip resource](#). This will show your Home Strip, Clash strip and the club you potentially will clash with. If there is an error, then email me with the correct image or information. You will be asked questions in the nomination form about your uniform.

### ADDITIONAL INFORMATION – OPTIONAL

Any additional information on reasons for a particular division request for any of your teams is to be submitted on club letter head and saved as a pdf file. This will be uploaded via the nomination form

Please note – Appeals may not be considered if relevant information was not provided with the nomination form.
